The major work will be delayed until the Town receives funding from the agency that ordered the traffic detour onto a road with a, spring breakup, posted weight limit.

Stewart also reported a Ho Chunk Highway Representative offered to place all Town Roads, except Bluebird Road, on their Bureau of Indian Affairs list of roads for construction. They can receive Federal funding, for road construction, which is not available to Towns. The Town would remain sole owner of all Town Roads. Chairman Stewart will contact our attorney for the legality of this action.

The Clerk was contacted by Attorney Lee Turonie with questions regarding what the Town wants in a cemetery ordinance. The attorney has researched County Restrictions and has started work on additional restrictions to be placed in our ordinance.
